Maryland Opioid Overdose Prevention Plan	The goal of this overdose prevention plan is to reduce unintentional, life-threatening poisonings related to the ingestion of opioids, including both illicit opioid drugs (i.e., heroin) and pharmaceutical opioid analgesics. The plan encompasses efforts to reduce poisonings related to the ingestion of opioids alone or in combination with other substances, as well as both fatal and non-fatal poisonings. The term "overdose" is used to describe poisonings that meet these criteria.
